NOTICE OF RECEIVER'S CLAIMS AND INTERESTS ANALYSIS REPORT

PLEASE CAREFULLY READ THE ENTIRETY OF RECEIVER'S CLAIMS AND INTERESTS ANALYSIS REPORT, INCLUDING THE ATTACHMENTS, AS YOUR RIGHTS COULD BE AFFECTED.

Pursuant to order dated June 14, 2022 [Dkt. 56], the Court appointed Melanie L. Cyganowski as Receiver (in such capacity, the "Receiver") of the Receivership Entities. On March 6, 2023, the Receiver filed her "Motion for Entry of an Order Establishing Procedures for Resolution of Claims and Interests and Setting Bar Dates for Claims" [Dkt. 168], which the Court granted by order dated March 30, 2023 [Dkt. 180] (the "Claims Order"), thereby establishing procedures for the resolution of Interests and Claims (the "Procedures") [Dkt. 168].

In accordance with the Procedures, the Receiver has prepared a Claims and Interests Analysis Report setting forth the Receiver's determination regarding Proofs of Claim and Investor Objections (as those terms are defined in the Procedures) that were submitted to the Receiver, and the Interests and Claims that the Receiver has determined to subordinate. The schedules (the "Schedules")² comprising the Receiver's Claims and Interests Analysis Report are annexed to this Notice. The Schedules do not necessarily provide the full basis for the Receiver's determination of any Claim or Interest, and the Receiver reserves all rights to provide further, different and additional bases for her determinations.

¹ The terms "Receivership Entities" and "StraightPath" refer to the following entities: StraightPath Venture Partners LLC ("SPVP"), StraightPath Management LLC ("SPM"), SP Ventures Fund LLC, SP Ventures Fund 2 LLC, SP Ventures Fund 3 LLC, SP Ventures Fund 4 LLC, SP Ventures Fund 5 LLC, SP Ventures Fund 6 LLC, SP Ventures Fund 7 LLC, SP Ventures Fund 8 LLC, and SP Ventures Fund 9 LLC.

² Except as otherwise defined in this Notice or the Schedules, all capitalized terms shall have the meanings ascribed to them in the Receiver's Plan of Distribution [Dkt. 368-1] that was approved by Court order dated November 26, 2024 [Dkt. 408].

The Schedules categorize the Claims and Interests into groups that are deemed to share common characteristics, as follows:

- 1. <u>Schedule A: Claims Filed by Investors.</u> These are Proofs of Claim filed by Investors on account of Interests.
- 2. <u>Schedule B: Commercial Claims.</u> These are Proofs of Claim filed on account of pre-Receivership agreements.
- 3. **Schedule C: Governmental Claims.** These are Proofs of Claim filed by Governmental Entities.
- 4. <u>Schedule D: Determination Pending Further Information.</u> These are Proofs of Claim for which the Receiver's determination is pending.
- 5. <u>Schedule E: Disputed Interests.</u> These are Interests for which an Investor has filed or otherwise lodged an Investor Objection that has not yet been resolved.
- 6. <u>Schedule F: Subordinated Interests and Claims.</u> These include Proofs of Claim filed and/or Interests asserted by SP Agents.
- 7. **Schedule G: Unrecognized Claims.** These are Proofs of Claim that do not relate to StraightPath.

Please read all of the Schedules in their entirety. If a Claimant filed multiple Proofs of Claim, the Receiver may have categorized each of the Claims in different Schedules. Schedules B, C, D, and G list each Claimant alphabetically by name and by Claim Number. Schedules A, E, and F list each Investor by Investor Number.

The Procedures set forth how Claimants can object to the Receiver's determination of their Claim(s) as set forth in the Schedules. The Procedures can be obtained free of charge on the Receiver's website: https://www.straightpathreceivership.com/.

In accordance with the Procedures, an objection to the Receiver's determination of a Claim must be (i) be in writing, (ii) state with particularity the basis and nature of the objection (as to which the Receiver reserves all rights) and (iii) be electronically mailed to the Receiver's counsel at StraightPathReceiver@Otterbourg.com so as to be actually received not later than 45 days after the date of this Notice. Objections should not be filed with the Court.

Further, if any Investor disagrees with the Receiver's treatment of its Interest as set forth herein, the Investor may seek to resolve any dispute or otherwise proceed in accordance with the Procedures, as to which the Receiver reserves all rights.

The Receiver's determination of a Claim or Interest shall be final and binding for all purposes, including with respect to the Plan, unless the Claimant or Investor, as applicable, timely and properly submits an objection or takes other action as set forth in the Procedures.

Please note that nothing in this Notice or the Schedules is intended to or shall be deemed to (i) affect, modify or limit any provision of the Procedures or the Plan, which shall be enforceable according to their terms, or (ii) state or guarantee any distribution on account of any Claim or Interest.
